To provide internal audit assurance by executing ICT audits on Namport's ICT systems, process and controls and drive the identification of potential vulnerabilities, risks and weakness in ICT systems. The role further provide recommendation for ICT improvement and remediation to management as required to support the realization of Namport's strategic objectives. The role reports directly to the Manager: Internal Audit.

- · Conduct ICT risk assessment by understanding business objectives, internal controls, enabling technology, and ICT infrastructure.
- Plan specific ICT internal audits.
- Review and develop comprehensive audit programs and relevant processes.
- Perform audit work over various technologies utilized by the company and various ICT functions. Assess both the design and operating effectiveness of internal controls.
- Prioritize and assist in scheduling audit tests to be performed, and interact with auditees to obtain the necessary information.
