9. Best Evaluated Bid:

The lowest price from Penatu Trading / PMPH Construction CC JV is N\$1 148 784.34 (28%) lower than the Consulting Engineer's cost estimate and is N\$ 925 617.00 (24%) less than the second lowest responsive bidder. The lowest bidder's price is therefore considered to be underpriced and below market rates. It is therefore not recommended to accept the lowest bid, as the bidder is likely to run into financial complications due to underpricing and likely not able to complete the project.

With the above mentioned, Rio Civils / LA Eng and Mining Construction JV therefore becomes the best substantially responsive bidder to all bid requirements.
